Chairman Huffman established a quorum was present at 10:02 a.m. and called the meeting to order.

**Open Session Minutes:**

Mr. Tolbert made a motion to approve the Open Session minutes of the January 19, 2022, meeting, as presented. Ms. Farrell seconded the motion. The motion carried unanimously.

**The Georgia Society of Certified Public Accountants:**

Mr. Cook gave an update on operations at the Georgia Society of CPAs and bills in legislative session. House Bill 911: A BILL to be entitled an Act to make and provide appropriations for the State Fiscal Year beginning July 1, 2022, and ending June 30, 2023; to make and provide such appropriations for the operation of the state government and its departments, boards, bureaus, commissions, institutions, and other agencies, for the university system, common schools, counties, municipalities, and political subdivisions, for all other governmental activities, projects, and undertakings authorized by law, and for all leases, contracts, agreements, and grants authorized by law; to provide for the control and administration of funds; to provide an effective date; to repeal conflicting laws; and for other purposes. HB911 would increase the GSBA's budget.

House Resolution 1055, A RESOLUTION recognizing and commending Julian I. Deal, CPA, and former GSBA Board Chair, was sponsored by Senator Billy Hickman, 4<sup>th</sup> District; Representative John Carson, 46<sup>th</sup> District; and Representative David Knight, 130<sup>th</sup> District.

Ms. Addison joined the meeting at 10:19 a.m.

**NASBA Operations:**

Mr. Ziga reported that a new Georgia Coordinator will be announced soon.

Mr. Ziga discussed how NASBA handles CPA exam credit extensions for the Board.

**Board Operations:**

Mr. Ziga had a conversation with the Georgia Building Authority regarding 150 boxes of GSBA files transferred from the Secretary of State's Office in 2014, currently in a storage room that is being terminated. Mr. Ziga stated that the boxes will be prepared for Georgia Archives after the firm renewal period has ended.

**Executive Director Report:**

Mr. Ziga reported the following:

- There are currently 22,696 Active CPAs and 2,096 Active firms in Georgia.
- The individual CPA license renewals are in the late renewal period. So far, 87.9% of licensees renewed through March 22, 2022. There are 2,601 licensees that have not renewed.
- Firm Renewals will be generated on March 31, 2022, and the first notice to renew will go out on April 1, 2022. Reminders will be sent in May and June 2022. The Peer Review requirement for renewal may be a concern due to COVID delays and backlog.
- Mr. Ziga and Ms. Harrison-Roberts were approved for scholarships to attend the NASBA 40<sup>th</sup> Annual Conference for Executive Directors and Board Staff, April 25-27, 2022, in Clearwater, Florida.
- The first CPE Audit selection of 125 licenses will take place in early May 2022.
- Mr. Ziga attended three meetings regarding the FY22 and FY23 budgets. FY23 looks promising to provide additional funds for Board operations, however, the FY22 budget remains unchanged. The GSBA will make every effort to meet the FY22 budget.






