**Open Session Minutes:**

**Executive Director Report:**

Mr. Ziga reported the following:

- There are currently 22,880 Active CPAs and 2,096 Active firms in Georgia.
- There are 2,177 individual CPA license renewals that are still pending renewal.
- Firm Renewals started on April 1, 2022. Email reminders went out May 16, 2022. So far about one-third of the firm licenses have been renewed.
- Mr. Ziga gave highlights of the NASBA ED & Legal Joint Conference he attended in April.
- The first CPE Audit selection of 131 licenses took place on May 12-13. The feedback has been positive.
- The FY22 budget is anticipated to be slightly over. The FY23 budget has been approved and signed by Governor Kemp.
- Mr. Ziga and Chairman Huffman will present a Board Update at the GSCPA Annual Convention in June.
- NASBA gifted the GSBA with 3 scholarships to the Eastern Regional Meeting in June.

**Executive Session:**

**Other Issues:**


The Board had a discussion on CPE Ethics, the Task Force for A&A recommendations, and the Board Rules drafting process.




