**Open Session Minutes:**

Mr. Tolbert made a motion to approve the Open Session minutes of the July 13, 2022, meeting, as presented. Ms. Farrell seconded the motion. The motion carried unanimously.

Mr. Ziga mentioned that the Board office has temporary moved to the 15<sup>th</sup> floor until the permanent office is ready.

**Executive Director Report:**

Mr. Ziga reported the following:

- There are currently 21,100 Active CPAs and 2,073 Active firms in Georgia.
- On August 1, there were 2,043 individual CPA license renewals that were lapsed for failure to complete the renewal.
- Firm renewals are ongoing through October. There were 1,817 renewals that have been processed with 2 applications still in-process, 94 firms closed and/or superseded, and continued follow up for the remaining 184 firm licenses pending renewal.
- Discussed NASBA's proposed recommendation for a uniform score extension for CPA Evolution scoring delays.
- Discussed NASBA's request for unified Rule on Score Release Date for start of 18-month exam credit period.
- There were 14 resumes received by SAO HR for the new GSBA staff position.
- In the process of reviewing 2 cloud-based options for an improved Licensing Database.
- There were 639 CPE Audit selections for May – September.

**Board Member Reports:**

The CPE Task Force discussed proposed changes to the CPE requirements. A special Board meeting will be held on October 25, 2022, at 1:00 p.m. for public discussion and to obtain Board approval to send the proposed changes to the CPE requirements to the Attorney General's office for legal review.

Mr. Ziga informed the Board that he and Mr. Smith will be attending the NASBA Annual Meeting October 30, 2022 – November 2, 2022, in San Diego, California.




