A meeting of the Georgia State Board of Accountancy was held via Teams on Wednesday, September 18, 2024.

Interim Chair Farrell established a quorum was present at 10:05 a.m. and called the meeting to order.

Open Session Minutes:

Mr. Tolbert made a motion to approve the Open Session minutes of July 10, 2024 with corrections. Mr. Inlow seconded the motion The motion carried unanimously.

Board Office Operations:

Mr. Ziga gave an update on Board Office and NASBA Operations.

The Georgia Society of Certified Public Accountants:

Mr. Cook and Mr. Search gave a presentation to the Board on the legislative process with respect to licensing changes and the Georgia Pathway to CPA.

Executive Director Report:

Mr. Ziga reported the following:

- There are currently 21,203 Active CPAs and 2,025 Active firms in Georgia.
- There were 20,248 CPA licenses renewed. There were 1,632 unrenewed licenses placed in Lapsed status.
- There have been 1,805 firm licenses renewed, 8 firm license renewals in process, and 90 firm licenses closed. There are 165 unrenewed firm licenses.
- Mr. Ziga reviewed and approved 15 GA Specific Ethics CPE Offerings which are posted on the website. Licensees are inquiring about a no cost option.
- Mr. Ziga and five Board Members will be attending the NASBA Annual Conference in Orlando, Florida on October 27-30, 2024.
- Mr. Ziga will present to Emory's MPA Class on September 20, 2024.
- Mr. Ziga will meet with the OPB Director on September 25, 2024 to discuss budget needs and show the historical contribution of the Board to the State Treasury.

Ms. Mooney joined the meeting at 10:14 a.m.

Mr. Search and Mr. Cook left the meeting at 12:30 p.m.

Executive Session:

At 1:00 p.m., Mr. Inlow made a motion to enter Executive Session in accordance with O.C.G.A.43-1-2(k) and 43-1-19(h) to deliberate on applications and investigative matters and to receive an investigative report. The Board was presented with a Board Rule Waiver Request for a waiver of sitting for the CPA exam. Discussion was held and there is no provision for a waiver of Statute 43, therefore, the exam is required and the request was denied.

Attorney General's Report:

Ms. Simpson gave a status report of cases referred to the Attorney General's Office. There are 15 cases going to OSAH for hearings. No Board action required at this time.
