Chairman Deal established a quorum was present at 10:00 a.m. and called the meeting to order.

Open Session Minutes:

Mr. Huffman made a motion to approve the Open Session minutes of the January 11, 2017 board meeting as presented. Mr. Mixon seconded the motion. The motion carried unanimously.

Executive Session:

At 10:02 a.m., Mr. Smith made a motion to enter Executive Session in accordance with O.C.G.A.43-1-2(k) and 43-1-19(h) to deliberate on applications and investigative matters and to receive an investigative report. Mr. Mixon seconded the motion. Voting in favor of the motion were those members present who included Chairman Deal, Ms. Addison, Mr. Martin, and Mr. Huffman. No votes were taken in Executive Session.

Chairman Deal declared open session at 1:05 p.m. to vote on discussions held in executive session.

Appearances/Appeals:

Applicant R.K.: After reviewing additional documentation received to appeal the Board's decision, Mr. Mixon made a motion to refer this applicant to the Attorney General's Office to amend the previously issued consent agreement to require applicant to obtain three hours of upper-level accounting semester hours by December 31, 2018. Ms. Addison seconded the motion. The motion carried unanimously.

NASBA Applications:

The following requests from NASBA were reviewed at the March 22, 2017 meeting:

Applicant J.G.: After reviewing the request for reciprocal licensure with special consideration of the education requirement, Mr. Smith made a motion to approve this applicant for reciprocal licensure. Mr. Mixon seconded the motion. The motion carried unanimously.

Applicant S.dP.: After reviewing the request for initial licensure with special consideration of the education requirement, Mr. Huffman made a motion to approve this applicant for initial licensure. Ms. Addison seconded the motion. The motion carried unanimously.

Applicant J.H.: After reviewing the request for initial licensure with special consideration of the education requirement, Ms. Addison made a motion to approve this applicant for initial licensure. Mr. Huffman seconded the motion. The motion carried unanimously.

Applicant S.M.G.: After reviewing the request for initial licensure with special consideration of the education requirement, Mr. Huffman made a motion to approve this applicant for initial licensure. Mr. Martin seconded the motion. The motion carried unanimously.

Applicant S.G.: After reviewing the request for initial licensure with special consideration of the experience requirements, the Board instructed staff to refer to NASBA to inform applicant that he must reinstate his Louisiana CPA license and then reapply for a reciprocal license with Georgia. No Board action taken.

Applicant S.Z.: After reviewing the request for initial licensure with special consideration of the experience requirements, Mr. Smith made a motion to approve this applicant for initial licensure. Mr. Huffman seconded. The motion carried unanimously.

Applicant S.C: After reviewing the request for initial licensure with convictions, the Board instructed staff to refer to NASBA to request an explanation of convictions and if applicant completed any programs to ensure those things do not happen again. No Board action taken.

NASBA Examination Requests:

Applicant L.W.: After reviewing the request to extend credit for the BEC exam until July 31, 2017, Mr. Smith made a motion to grant a one-time extension. Ms. Addison seconded the motion. The motion carried unanimously.

Enforcement Report:

Ms. Addison presented the following enforcement cases requiring board action:

Ms. Addison made a motion to accept the recommendations. Mr. Mixon seconded the motion. The motion carried unanimously.

ACCT150049 – The Board voted to refer this case to the Attorney General’s Office for a consent order assessing a \$2,000 fine for unprofessional conduct and proof that the SEC judgement has been satisfied.

ACCT170017– The Board voted to refer this case to the Attorney General’s Office for a Cease & Desist and a letter to the Massachusetts Board of Public Accountancy.

ACCT170022 – The Board voted to refer to Investigations to send a letter for failure to respond.

ACCT170029 – The Board voted to refer to Investigations to send a letter suggesting that licensee obtain four additional hours of CPE in Audits.

ACCT170033 – The Board voted to close due to insufficient evidence of any violation of the board’s rules. The Board reserves the right to reopen this case after suit against CPA is closed.

ACCT170034 – The Board voted to table until civil suit concludes and refer to Investigations for monitoring.

ACCT170035 – The Board voted to table until civil suit concludes and refer to Investigations for monitoring.

ACCT170037 – The Board voted to close with no action.

Attorney General’s Report:

Ms. Williams-McNeely presented a status report to the Board of cases and advice referred for action.

Applicant V.S.: After reviewing the request for a waiver of CPE requirements for the 2015 renewal period pursuant to Rule 20-11-.02 (6), Mr. Smith made a motion to deny the request, no hardship determined. Ms. Mixon seconded the motion. The motion carried unanimously.

Ms. Williams-McNeely informed the Board that there were 63 referrals to the Attorney General’s Office for the 2015 CPE Audit period and provided an update for each case.

Approval of Executive Session Minutes:

Mr. Martin made a motion to approve the Executive Session minutes of the January 11, 2017 Board as presented. Mr. Huffman seconded the motion. The motion carried unanimously.

Mr. Ziga informed the Board that there are currently 20,767 Active CPAs and 1,842 Active firms in Georgia.


Mr. Ziga gave the Board highlights of the NASBA's Executive Director Conference he attended March 14-16, 2017 in New Orleans, LA.


Mr. Ziga stated that GSBA is on budget through the first half of the fiscal year and gave a Revenue Report.



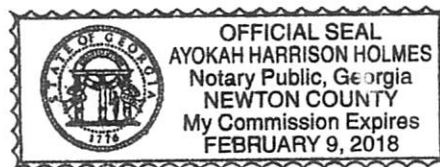
