ACCT180033: The Board voted to refer this case to the Attorney General's Office for a consent Agreement assessing a \$12,000 fine for unlicensed practice.

ACCT180034: The Board voted to refer this case to the Attorney General's Office for a consent Agreement assessing a \$8,000 fine for unlicensed practice.

Mr. Ziga stated that FY2018 is on budget and distributed a revenue report.

Mr. Ziga informed the Board that he is looking for a new system for document sharing.


Board Member Report:


