D.S.T.: After reviewing the article regarding insider trading, the Board made a recommendation to refer to Mr. Bobo pursuant to Board Rule 43-3-.21.

Mr. Bobo presented the Board with recommendations for revisions to the online complaint form and ways to streamline the complaint process.

**Approval of Executive Session Minutes:**

Mr. Johnson made a motion to approve the Executive Session minutes of the July 30, 2014 Board meeting with recommended corrections. Ms. Goodson seconded the motion. The motion carried unanimously.

**Ratification of Licenses Issued:**

Mr. Johnson made a motion to approve the following applications that met certification requirements. Mr. Bobo seconded the motion. The motion carried unanimously. The Board approved one hundred fifty (150) Certified Public Accountant licenses (CPA032405 to CPA032555) and eighteen (18) Public Accounting Firm licenses (ACF006210 to ACF006228) since the July 30, 2014 Board meeting. **Other Business:**

Mrs. Schoubert presented a proposal from NASBA regarding the service of printing and mailing plastic license cards to new licensees. Mr. Bobo made a motion to replace the paper license and wallet card with the new plastic license card due to a NASBA initiative to provide a uniform, secure license to all licensed CPAs and firms and to increase the license fees to support this service. Ms. Goodson seconded the motion. The motion carried unanimously. Requests for plastic license cards and wall certificates will now be issued by NASBA and purchased through the NASBA store.

The Board had a discussion on individual CPAs practicing as a firm without a firm registration. The Board voted to grant amnesty to those individuals who are not in compliance. Those individuals must apply for a firm registration through NASBA by June 30, 2015.

The Board reviewed the request for biographies and pictures of Board members for posting on the GSBA website. The Board voted unanimously to not include bios and pictures on the website.

The Board discussed revisions to the remaining Board Rules. The Board will vote to post all drafted Board Rules, the Synopsis and Notice of Intent at the November 19, 2014 meeting.

The Board reviewed the budgets for FY2015 and FY2016. Ms. Goodson made a motion to approve the budgets as presented. Mr. Bobo seconded the motion. The motion carried unanimously. The GSBA offices will remain with the State Accounting Office through FY2016.

The Board had a discussion on proposed legislation for the next legislative session. Mr. Bobo made a motion to include the Executive Order that the Georgia State Board of Accountancy is administratively attached instead of a division of the State Accounting Office and to add five board rules that were left out of House Bill 291. Ms. Goodson seconded the motion. The motion carried unanimously.


**Committee/Subcommittee Reports:**
